Approval of Minutes for March 28, 2023 Board Meeting

Consent Agenda Approved.

Programs/Roots and Shoots - Colette Rudd and Mary Powell

- R&S is one of the most special and loved program at Gamble, introduced in 1985
- The current program is a garden-based science field trips for students in grades K-3
- R&S curriculum is tied to the CA State Science Standards for grades K-3.
- We can handle a max of 46 students at a time and break into groups of 7-8 children, each with a Garden Guide.
- Schools have the option of a one-time field trip or a sequence..
- R&S delivered programs between Jan May, completing 14 sessions for 426 student visits.
- R&S has a list of managerial tasks too much for a volunteer.

R&S goals for this year:

- Create a scalable model for R&S to serve many schools and return visits.
- Move to a fixed, one day per week R&S program.
- Develop and train a core of trained committed Garden Guides.
- The potential is great we can run this program most Thursday during the 32-week school year.
- Develop a detailed business plan for growing the program.

The Executive Director was supportive of the recommendation by the R&S Committee to hire a 30 hour per week staff person for Programming.

Finance Report: Karen Douglas

- Quarterly Finance Report
 - o Gamble has completed 10 months of FY23.
 - o Operating revenue is 124% of budget.
 - o All revenue generating categories are exceeding plan.

- We are favorable to salary and wages but that is because we are not fully staffed to budget.
- o Endowment added three benches and two bricks this FY.

FY24 Budget

- The Finance Committee developed the FY24 budget with a focus on our approved goals. The main goal is the Garden House project.
- In the past, we have underbudgeted income for some of our major revenue streams. When
 developing the FY24, we reviewed current year and last year revenue and is in line with past
 income.
- We do not expect to end FY24 with the level of surplus we have had in the past.
- FY24 has budgeted staff salary increases averaging 6% for current employees and support for the Roots and Shoots program.

There are some necessary projects for FY24 that are not included in the operating budget.

In June the Finance committee will be prepared to discuss past undesignated bequests and large unsolicited gifts.
