Finance Report - Karen Douglas

Karen commented that there is nothing unexpected in the October 2023 Treasurer's Report and Commentary. For the reasons documented in the Gamble Garden Insurance Review / Improvement report, Gamble Garden has a new insurance broker. Amy will be working on the audit so any requests to her for information, checks etc. may take longer than normal.

Search Committee for Executive Director – *Joan Zwiep*

The Search Committee (Joan Zwiep, Norm Robinson, Corey A, Susan Sweeney, Karen Douglas, Dawn Hood) has met twice since the last board meeting. The committee checked with local firms to learn of their experience with Executive Search Firms. The committee has a list of seven firms and are in the process of evaluating them. The cost to Gamble Garden would be a one-time operating expense. The committee has not yet decided which type of services are needed and has not decided yet whether a search firm is needed. However, because the next board meeting isn't until late January, if a choice to hire a firm is made, the expectation is that the maximum amount of a firm's fee would be less than \$60,000.

MOTION: Karen Douglas moved that the board authorize Joan Zwiep, President, and/or Norm Robinson, interim Executive Director, to enter into a contract with an executive search firm selected in consultation with the Search Committee for services to recruit an Executive Director for an amount not to exceed \$60,000.
